TERMS & CONDITIONS

- 1) All rates are inclusive of GST/IGST and Transportation upto Distributor/SS Godown. However, Distributor/SS has to arrange Labour during arrival of goods at his Godown. - 3) Goods once sold will not be taken back in any condition. So Distributor/SS has to order the goods as per his requirements.
- 4) However, if Distributor is facing any difficulty in selling goods, than company will provide support by providing salesman or arranging to sell his goods to another distributor. In such case, transportation charges will be borne by Distributor/SS.
